

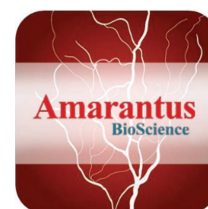

### Facts and Figures

- There were an estimated 44.4 million people with dementia worldwide in 2013. This number will almost double every 20 years and by 2050 there will be 135.5 million people living with dementia
- Nearly two-thirds of people with dementia live in low and middle income countries
- There is a new case of dementia somewhere in the world every four seconds
- The estimated cost of dementia in 2010 was USD 604 billion. This is 1% of global gross domestic product (GDP)
- If dementia care were a country it would be the world's 18th largest economy, ranking between Turkey and Indonesia
- The control of diabetes and high blood pressure as well as measures to encourage smoking cessation and to reduce cardiovascular risk, have the potential to reduce the risk of dementia even in late-life.

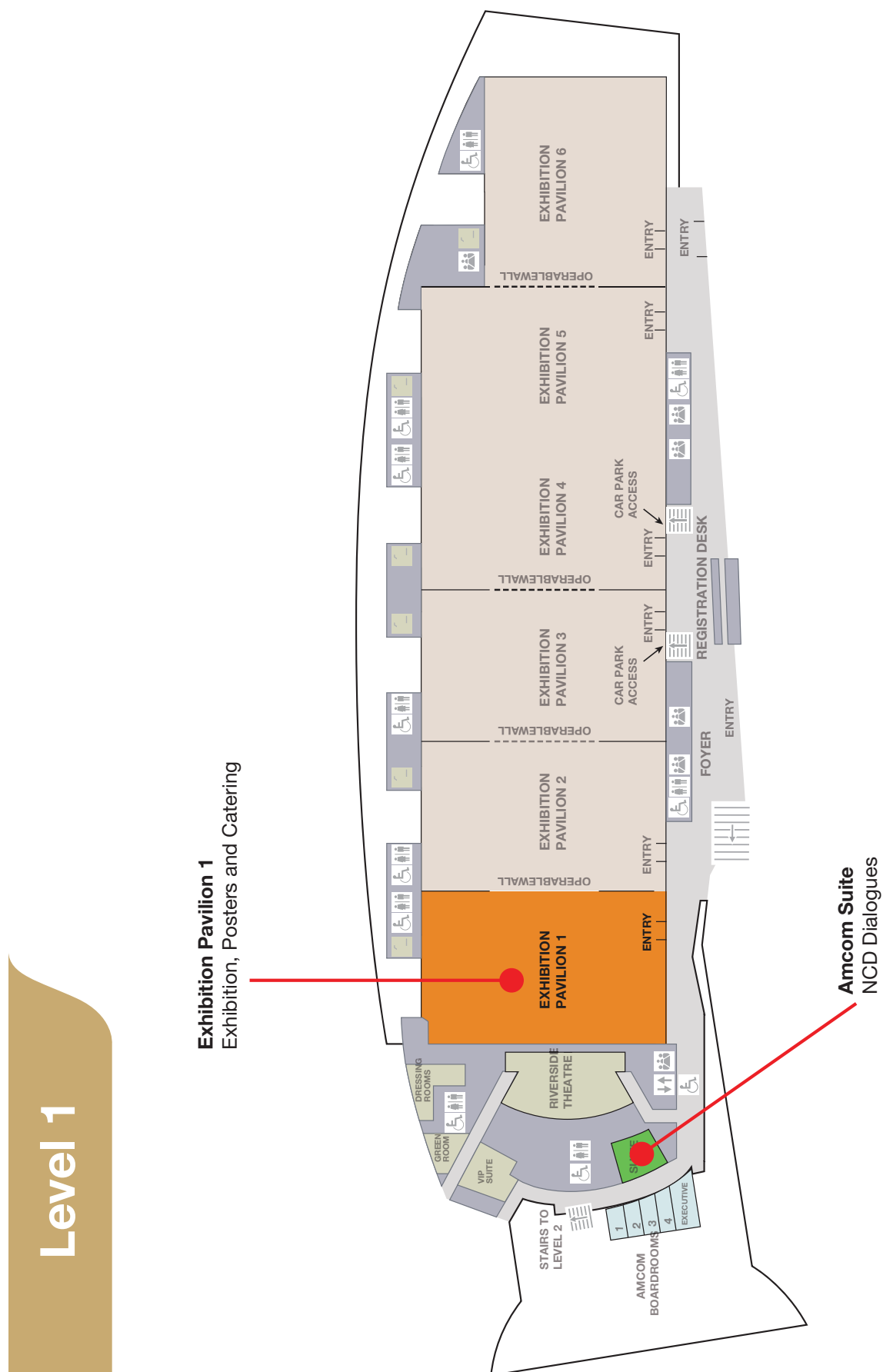

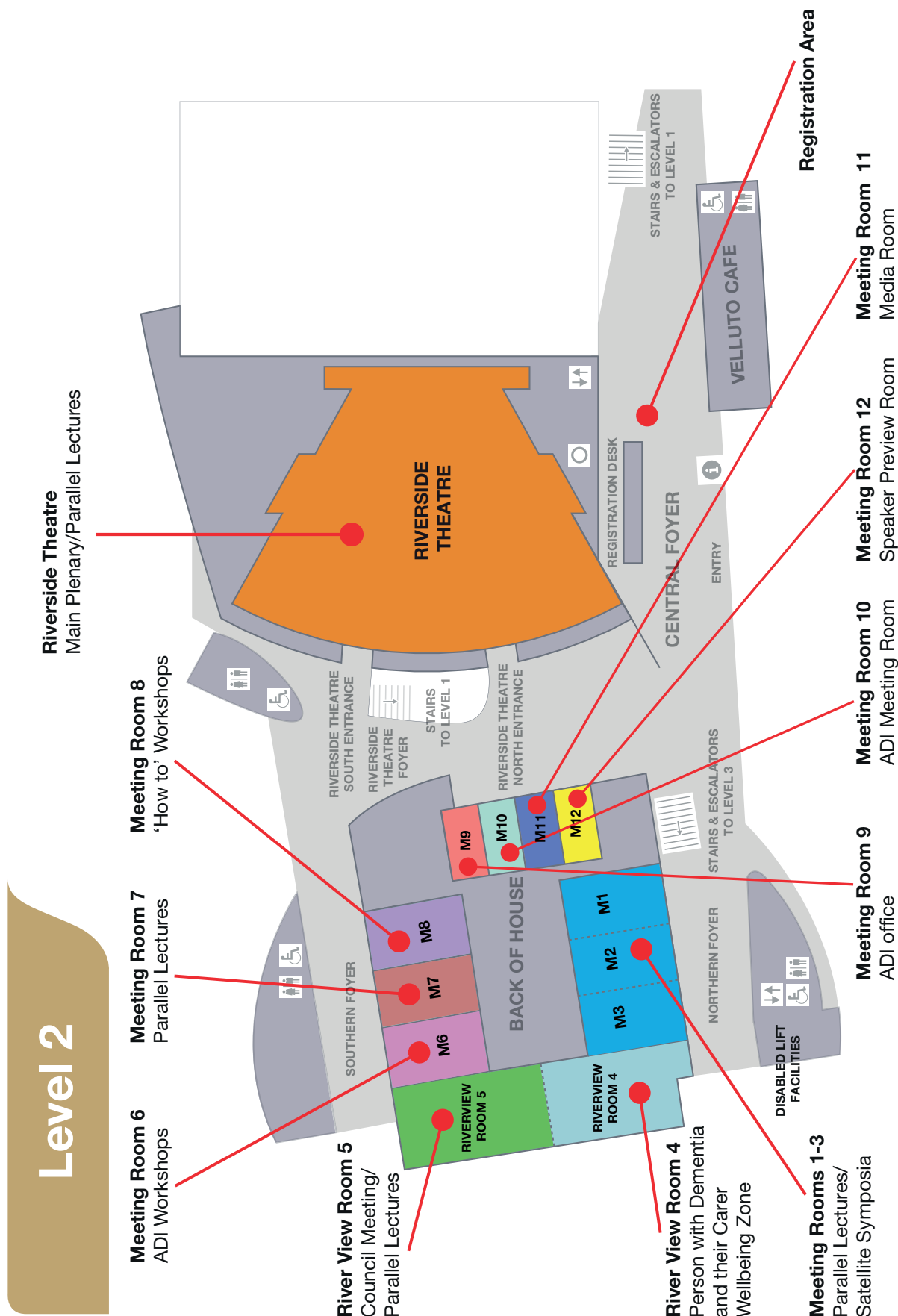
# Perth Convention and Exhibition Centre Layout: Level 1

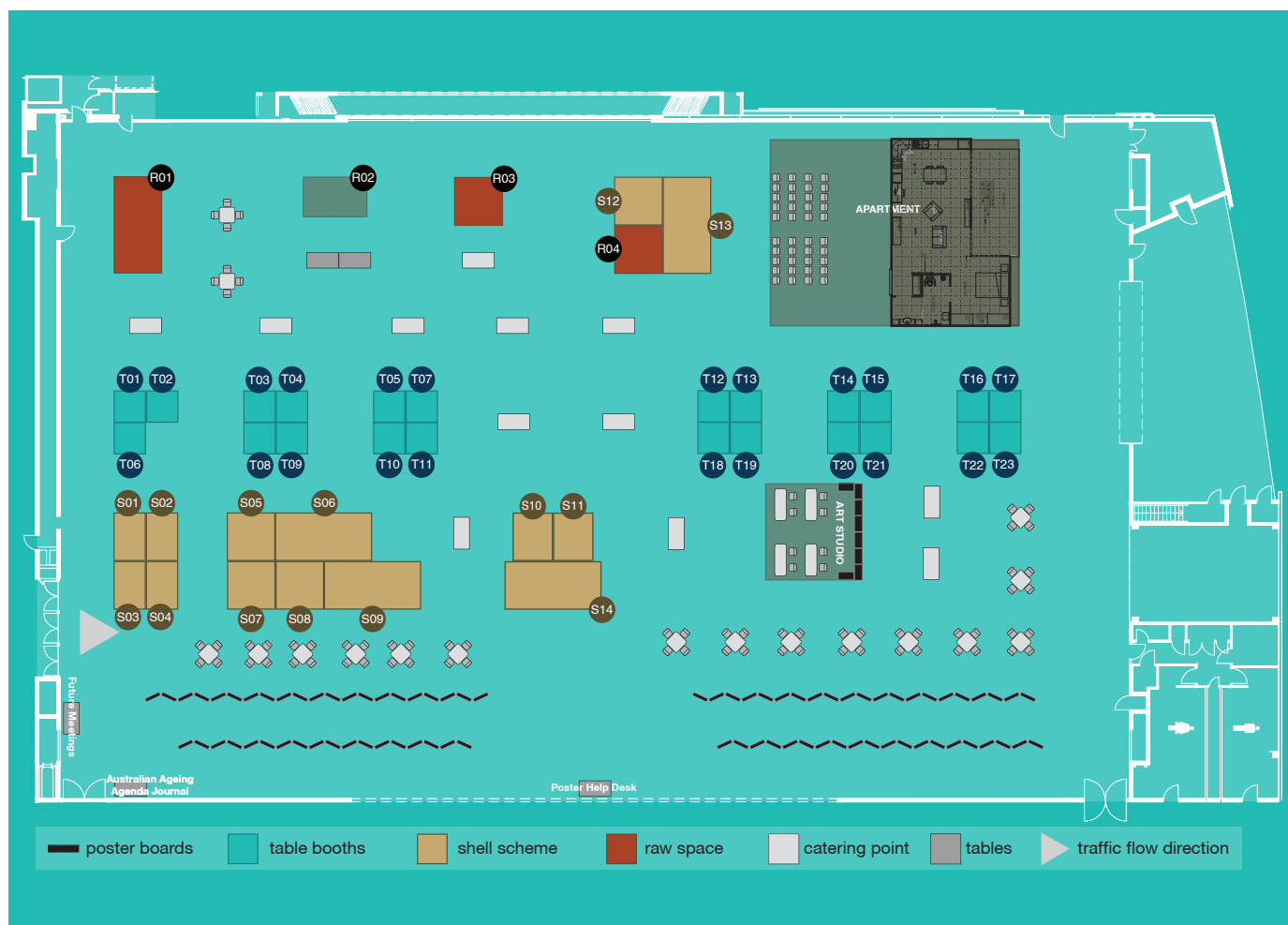

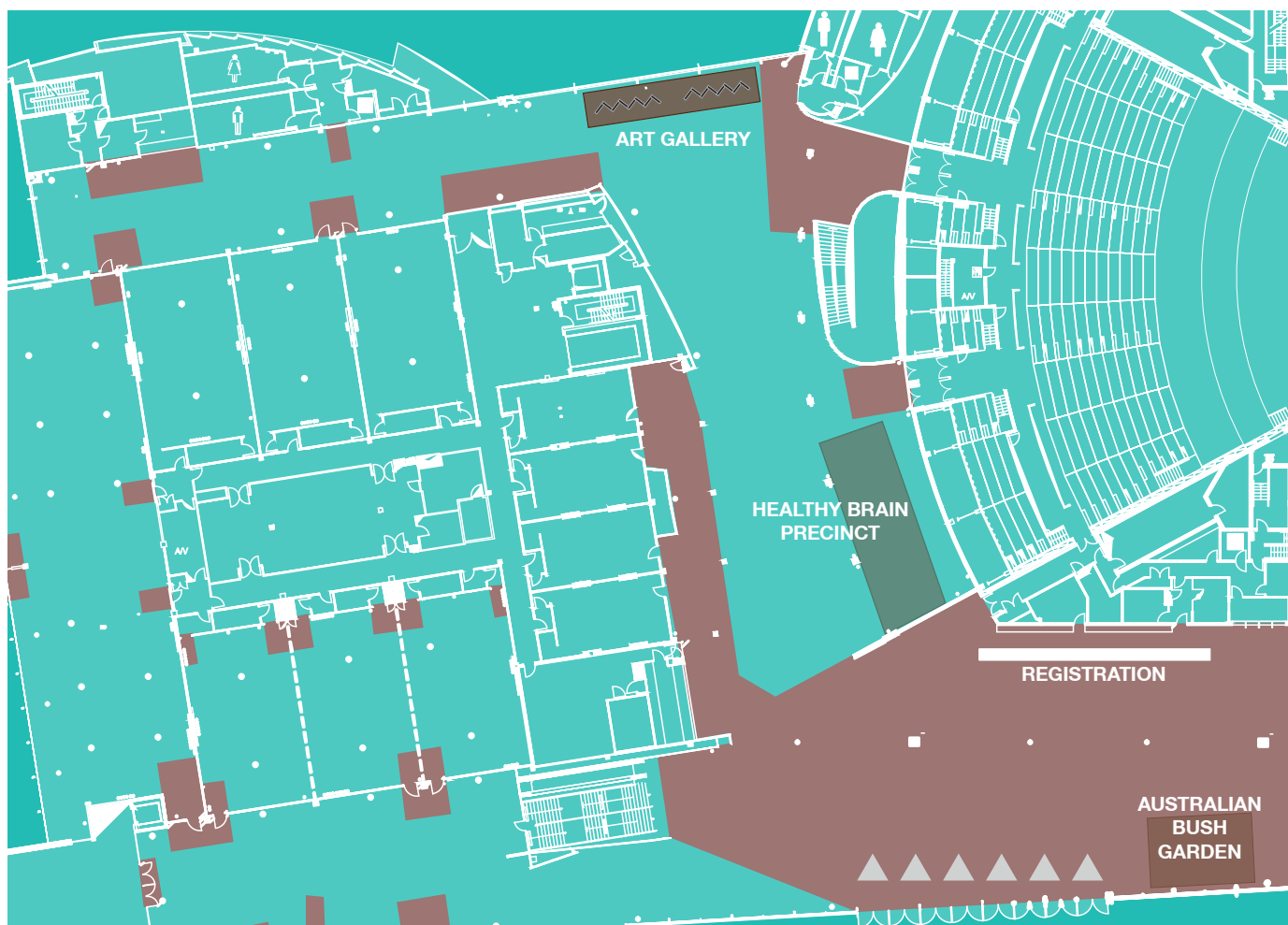

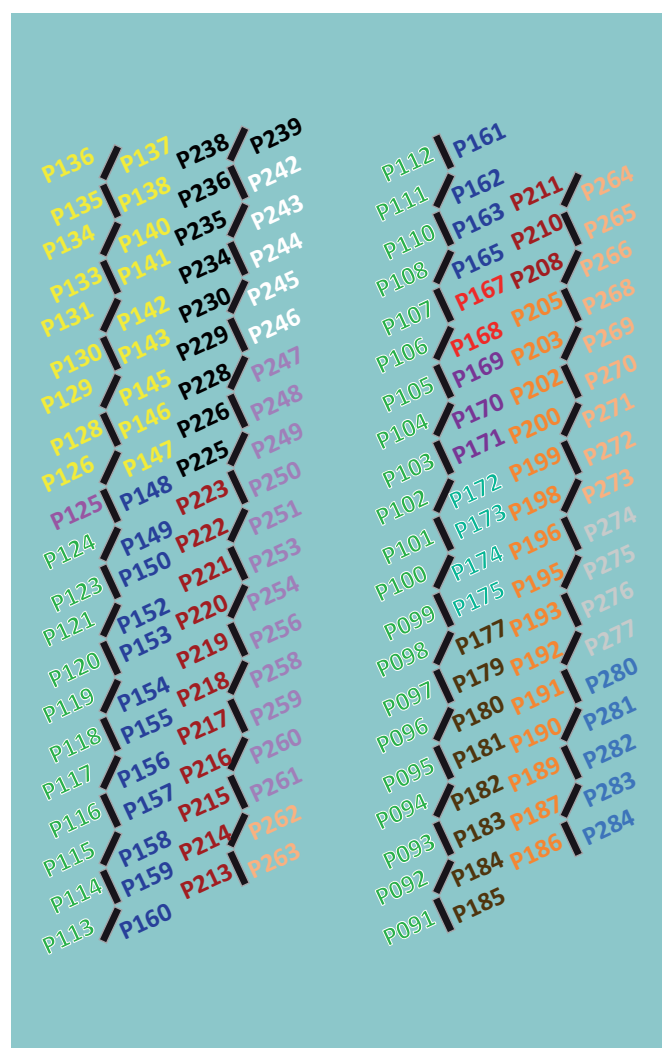

Previously she worked as a teacher of deaf children for 20 years and as a masseur for six years. Anne, her partner of 30 years, retired from private practice in Clinical Psychology and Psychoanalytic Psychotherapy last year. Edie is a member of the Alzheimer's Australia Victorian Reference Group and a member of the Alzheimer's Australia National Advisory Committee. They are both committed to improving understanding of Younger Onset Alzheimer's in the general community, improving services, particularly day-care, respite and permanent care facilities and supporting others with Younger Onset Dementia as well as their carers.

Serge  
Gauthier



Serge's career includes medical studies at Université de Montréal, Neurology training at McGill University, Research Fellowship at Prof. Theodore L. Sourkes laboratory, Allen Memorial Institute, Montreal. Clinical investigator and staff neurologist at the Montreal Neurological Hospital and Institute (1976-1986), Director of the McGill Centre for Studies in Aging (1986-1996), Senior Scientist of the CIHR-Rx&D program (1997-2007). Currently he is Professor in the Departments of Neurology & Neurosurgery, Psychiatry, Medicine, at McGill University, and Director of the Alzheimer Disease and Related Disorders Research Unit of the McGill Center for Studies in Aging, Douglas Hospital.

Contributions to research include design and implementation of randomized clinical trials in order to establish the safety and efficacy of cholinesterase inhibitors, muscarinic agonists, and agents possibly modifying progression for Alzheimer's disease and vascular dementia. Special interests include consensus approach to the management of dementia in different stages, the ethics of research involving persons with dementia, and primary prevention strategies against cognitive decline and dementia.



## Keynote Speaker Biographies

Martin  
Prince



Martin Prince is Professor of Epidemiological Psychiatry, Head of Department of the Health Service and Population Research department, and joint-Director of the Centre for Global Mental Health which is a joint King's Health Partner and London School of Hygiene centre. He trained in Psychiatry at the Maudsley Hospital and in Epidemiology at the London School of Hygiene and Tropical Medicine.

His work is oriented to the salience of mental and neurological disorders to health and social policy in low and middle income countries (LMIC), with a focus on ageing and dementia. He has coordinated, since 1998 the 10/66 Dementia Research Group, a network of researchers, mainly from LMIC working together to promote more good research into dementia in those regions. The group has published 100 papers covering dementia prevalence, incidence, aetiology and impact and contributed to knowledge of public health aspects of ageing and chronic disease in LMIC.

He was co-author of the Dementia UK report that informed the UK Government's National Dementia Strategy. He led the development of the widely reported ADI World Alzheimer Reports for 2009 (prevalence and numbers), 2010 (societal cost) and 2011 (early intervention) and was a leading contributor to the WHO World Dementia Report 2012. He was one of three editors for the 2007 Lancet Series on Global Mental Health, and is committed to further research and advocacy to support the call for action for improved coverage of evidence-based community treatments. He coordinated the development of the WHO Mental Health Gap Action Plan (mhGAP) clinical guidelines for dementia care by non-specialists in LMIC.

Rees



Glenn Rees has worked at senior levels in the British and Australian Public Services. In Britain he worked as Private Secretary to senior Ministers, in the Cabinet Office and in Economic Departments. In Australia since 1976 he has worked in program and policy areas including Prime Minister and Cabinet, Employment and Training, Aged Care, Disabilities, Housing and the Aboriginal and Torres Strait Islander Commission. He was Chair of the Nursing Homes and Hostels Review in 1986 and was involved in implementing the first wave of aged care reforms. He was CEO of Alzheimer's Australia from 2000 – 2014 and has recently stepped down from this position. During his time as CEO the Dementia Initiative was implemented in 2005 and important commitments made to tackle dementia in the 2012 Aged Care reforms. Dementia is now a National Health Priority Area. He is an active member of the National Aged Care Alliance and is a member of the new Aged Care Sector Committee. He is Chair Elect of Alzheimer's Disease International (ADI).

#### Tackling Dementia and Non-communicable Diseases Together: Shared Risk Factors, Shared Solutions

##### **Mr Marc Wortmann - CEO, Alzheimer's Disease International**

Marc Wortmann is Executive Director of Alzheimer's Disease International (ADI). Marc studied Law and Art in the city of Utrecht in the Netherlands and was an entrepreneur in retail for 15 years. During this time Marc was a member of the Parliament of the Province of Utrecht and worked closely with various charities and voluntary organisations. He became Executive Director of Alzheimer Nederland in 2000. From 2002 to 2005 he chaired the Dutch Fundraising Association and was Vice-President of the European Fundraising Association from 2004 to 2007. Marc joined ADI in 2006.

##### **Ms Katie Dain – Executive Director, NCD Alliance**

Since joining the NCD Alliance in 2009, Katie's experience has included organizational and strategic development; global advocacy and policy-making; and program design and capacity-building in low- and middle-income countries. Katie is widely recognized as a leading advocate and expert on NCDs, and has authored or co-authored numerous papers and commentaries on global health and development policy issues. Before joining the NCD Alliance, Katie worked at the International Diabetes Federation (IDF) in Brussels, leading their global advocacy programme and establishing the first Women and Diabetes programme. Katie has a Master's degree in Violence, Conflict and International Development from the School of Oriental and African Studies (SOAS), London.

##### **Professor Henry Brodaty, University of New South Wales**

Henry Brodaty is both an academic and a clinician; holding posts including Scientia Professor of Ageing and Mental Health and Director of the Dementia Collaborative Research Centre at the University of New South Wales; and Head of the Memory Disorders Clinic at Prince of Wales Hospital, Sydney. He has been at the forefront of consumer and professional groups for people with dementia and their families, including as former chairman of Alzheimer's Disease International, president of Alzheimer's Australia, and currently as president of the International Psychogeriatric Association. In Australia, he sits on several committees concerned with dementia and mental health in older people. Professor Brodaty has published over 400 articles, together with numerous books and reports; and has received awards for research and community work.

##### **Dr Paul Zollinger-Read - Global Chief Medical Officer, Bupa**

Paul joined Bupa as its Global Chief Medical Officer in 2012. Within this role, he ensures that robust global systems of clinical governance are in place, that Bupa commissions and provides services based on the latest clinical evidence and to ensure that it provides innovative models of care. Paul has held a variety of posts within the UK National Health Service (NHS), including as a GP in Oxford, and in NHS management roles including CEO of several different Primary Care Trusts - regional bodies commissioning primary, community and secondary health services from providers. Paul studied medicine at Cambridge University and then at Guy's Hospital, London.





### Session 2

#### How Can Workplaces be Used to Help Tackle Dementia and Other NCDs?

##### **Mr Harry Johns – President and CEO, Alzheimer's Association**

Harry Johns is the President and CEO of the Alzheimer's Association, which has changed the public discussion about Alzheimer's in America, raising the epidemic and its devastating human and economic consequences to significant new levels of recognition and support. The Association was the non-profit organization engaged in developing and ensuring the passage of the National Alzheimer's Project Act, leading to the creation of a National Plan to address Alzheimer's Disease. The Association is a global Alzheimer's research leader, ranked only behind the U.S. National Institutes of Health and Chinese government in impact, according to Thomson Reuters and the most influential nonprofit for aging issues in the U.S., according to Philanthropedia.

##### **Dr Fiona Adshead - Chief Wellbeing and Public Health Officer, Bupa**

Fiona is responsible for leading Bupa's work on prevention, behaviour change, workplace health, and partnerships, as well as catalysing action on improving the health of the world by creating pathways to make people healthier in a commercially sustainable and globally recognised way. Previously, Fiona was Director of Chronic Disease and Health Promotion at the World Health Organization. She also held the positions of Deputy Chief Medical Officer and Director General in the UK Government, with responsibility for health improvement and health inequalities, including tobacco control, obesity, diet, physical activity, behaviour change and social marketing. Fiona has also worked as a Director at PwC in its health and sustainability team.

##### **Ms Kate Swaffer – Chair, Alzheimer's Australia Dementia Advisory Committee**

Kate Swaffer is Chair of the inaugural Alzheimer's Australia Dementia Advisory Committee, and Co-Chair of the Consumer Dementia Research Network. She is also co-chair, co-founder and editor of a global group for people with dementia, Dementia Alliance

International. She was the first paid consultant to be employed by Alzheimer's Australia as part of their dementia-friendly initiative. She completed a Master's of Science in Dementia Care at the University of Wollongong in 2014. Kate is an author, speaker and poet, and in her first career worked as a registered nurse in dementia care. She is also living well with younger onset dementia.

##### **Dr Laura Campo - Advisor, International Advocacy and Professional Relations, Eli Lilly and Co.**


Laura Campo is responsible for relationships with Patient Associations and Health Professionals, and coordinates efforts to engage the external environment in both Alzheimer's Disease and Autoimmune areas. Previously, Laura served as Corporate Affairs Market Access Manager at Eli Lilly Italia, supporting Regional access plans including those for cancer and CVD. During her time in the Italian Corporate Affairs Division, Laura was country leader for two initiatives, working closely with multiple stakeholders through educational programs and awareness campaigns, and raising awareness of public policy issues which limit access to care for Alzheimer's Disease and cancer. Laura pursued a post-doctoral fellowship at the University of Alabama at Birmingham and her graduate school in Italy.


##### **Ms Kathryn Smith – Director of Operations, Alzheimer's Society**

Kathryn joined the Alzheimer's Society in September 2012. Her management and leadership responsibilities cover all of the Society's operational services. Previously, Kathryn worked for Scope where she was the Director of Services. Kathryn has worked in social care since 1989, including work within the private sector, a Health trust, four different local authorities, and the Commission for Social Care Inspection (predecessor to the CQC). She has also taught various social work courses for Leeds University and the Open University. Kathryn also chairs the Guidance Development Group for Health and Social Care Transitions and is a trustee for Disability Advice Bradford.
